Any attempt by any entrant to obtain more entries by using multiple/different email addresses, or any other methods will void that entrant's plays/entries and that entrant may be disqualified. Sponsor assumes no responsibility for any computer, telephone, cable, network, satellite, mail service, electronic or Internet hardware or software malfunctions, failures, connections, availability, garbled or jumbled transmissions, or service provider/Internet/web site/use net accessibility or availability, traffic congestion, or unauthorized human intervention or the incorrect or inaccurate capture of entry information, or the failure to capture any such information. Any prize notification returned to the Sponsor or its agencies as undeliverable would result in disqualification.
